Early College Credit Enrollment Program Guidelines

High school students who participate in Early College Credit Program receive college credit for courses taken while still attending high school. College courses may also be used to fulfill high school graduation requirements. To participate in Early College, a high school student must:

- ☐ Be a junior or senior AND at least 16 years of age
- ☐ Possess a cumulative GPA of 2.7 or higher, 83 or better high school average, or B- or better grades in high school courses.
- ☐ Be certified by a counselor or school official of the high school as meeting all of the eligibility requirements as outlined above.

Payment of Tuition, Fees, and Books

Wilmington University Early College Credit courses have a charge of \$96 per (3) credit course. Students are also charged a (\$25) course registration fee occurring each semester enrolled. Students will be responsible for all textbooks needed for class.

University Registration Steps

1. Complete a new Early College Credit Application Form for each semester you plan to participate. (NEW AND RETURNING STUDENTS)
2. Complete the ACCUPLACER Test. (To be exempt from Accuplacer Reading Comprehension, Sentence Skills and WritePlacer, a 450 must be achieved on both the Critical Reading SAT and Writing SAT. To be exempt from Accuplacer Math a 450 must be achieved on the math SAT.) <http://www.wilmu.edu/admission/undergraduate.aspx>
3. On the day you plan to register for college classes, bring along your Early College Credit Application Form and submit it to your academic advisor. **Note:** Early College Credit students must register for courses in person and are *not* eligible to register online.

ACCUPLACER Test

All incoming students must take the ACCUPLACER Test prior to registering for English or Math classes. This test assesses your level of readiness for college level math and English coursework and specifically covers Reading Comprehension, Writing Skills, Elementary Algebra, and Arithmetic. Preparing to take the assessment will help you to achieve higher scores. A report containing your results is available after testing. An academic advisor can review your score results with you. Please review the resources below prior to taking the test. More information is also available at www.wilmu.edu. **Note: Retesting is not available.**
