

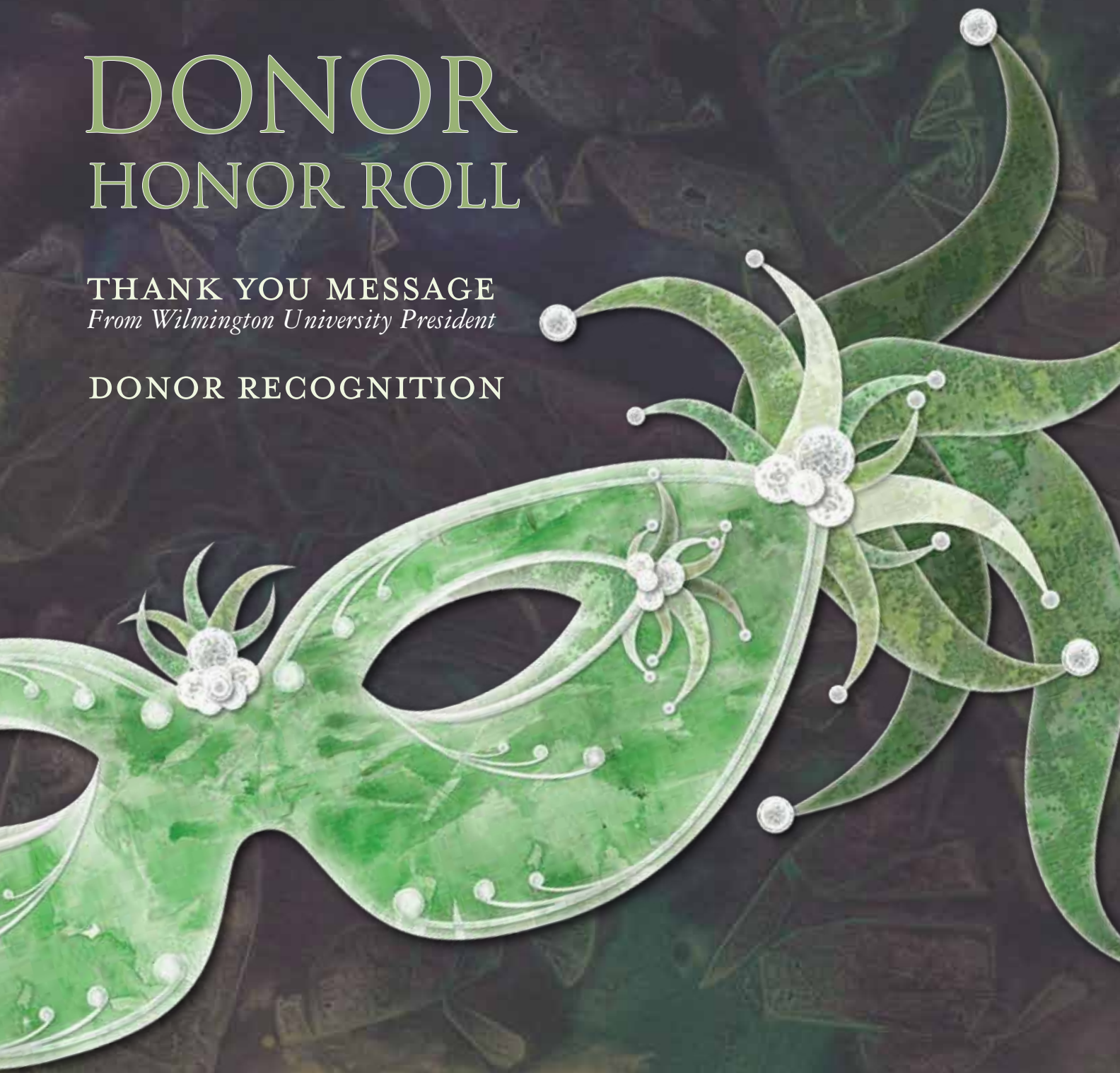

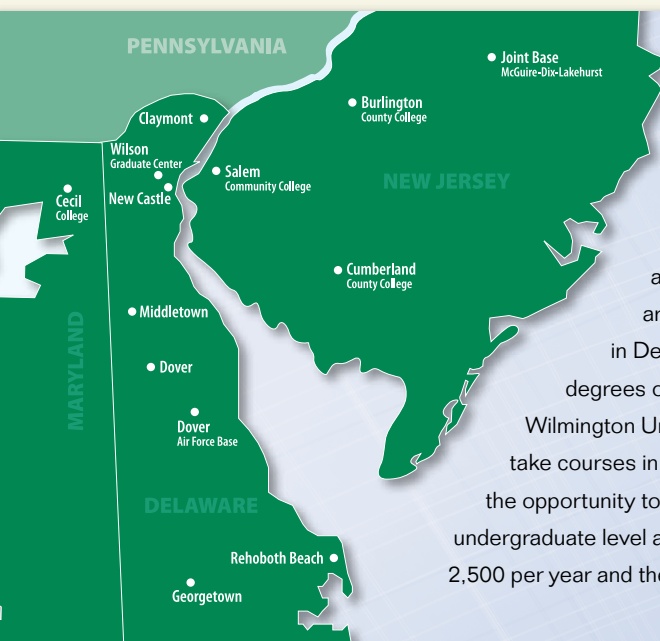

YOUR UNIVERSITY IS GROWING!

Wilmington University has continued to grow in both student population and academic acclaim since becoming a university on September 10, 2007. There are now 14,500 students registered for classes at the University at 11 locations in Delaware, New Jersey and Maryland. Students can choose from 34 undergraduate degrees or 27 graduate degrees in a variety of programs. Many students who attend Wilmington University are attracted to the flexible schedules, which allow students to take courses in the evening, during the day, online or on weekends. Students now have the opportunity to take 14 programs completely online. Ten of the programs are offered at the undergraduate level and another four are at the graduate level. Graduation classes now average 2,500 per year and the Alumni Association is 30,000 strong.

WILMINGTON ATHLETICS SPORTS PROGRAMS



You will be proud to know that the Wilmington University Wildcats' sports teams compete in the National Collegiate Athletic Association (NCAA) Division II in the Central Atlantic Collegiate Conference (CACC). WU athletes compete in a conference that is comprised of 14 colleges and universities throughout Delaware, New Jersey, Pennsylvania, New York and Connecticut.

Wilmington University fields teams in Baseball, Men's Basketball, Women's Basketball, Cheerleading, Cross Country, Golf, Women's Lacrosse, Men's Soccer, Women's Soccer, Softball and Volleyball. The Wildcats had seven student athletes named NCAA All-Americans in 2009-2010 and captured last season's regular season championships in men's soccer and baseball.

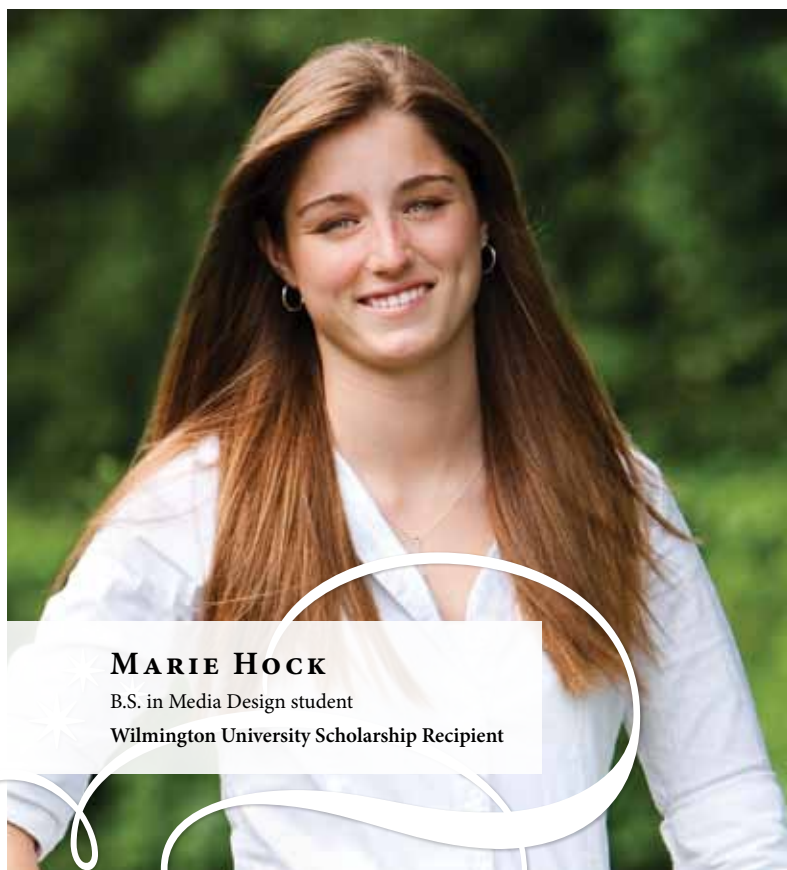
39 Wildcat athletes received All-Conference honors in their respective sports. The men's teams were honored by being named recipients of the Alfred R. Restaino CACC Commissioner's Cup for the highest overall scoring program in the Conference.

Wilmington University is proud that the student-athletes post a collective 3.0 grade point average. As student-athletes, 18 players were awarded Academic All-Conference accolades. Two in this group were named to the *ESPN Magazine* Academic All-District Team. 15 athletes received All-East Region honors.
