** This capstone course and a passing score on the Praxis II School Counselor 5422 exam are required before candidates complete their first clinical course in the program. Candidates must complete all 11 M.Ed. in Elementary and Secondary School Counseling (Certification/Licensure) academic courses in the appropriate sequence to meet prerequisite requirements as well as required supervised certification internships and seminars. Minimum GPA of 3.0 required.

Certification Track

This is a Delaware licensure/certification program with content knowledge and performance assessment requirements. Graduates of the M.Ed. in Elementary and Secondary School Counseling (Certification/Licensure) track are eligible for state licensure as a school counselor in public, private or charter schools.

This degree program is approved by the Delaware Department of Education and contributes to eligibility for Delaware certification as a school counselor. Program competencies are based on the School Counselor Competencies established by the American School Counselor Association (ASCA).
